### OVERVIEW/SUMMARY OF UPDATED GOVERNMENT DIRECTIONS

### **Easing of restrictions in Queensland**

From 6pm AEST Friday 4 March 2022 restrictions have eased for face masks and other public health and social measures.

- Venues and events no longer have density limits.
- There is no limit on the number of visitors you can have in your home at one time.
- Masks are no longer required indoors, except in healthcare settings, residential aged care, disability accommodation, prisons, public transport, airports and on planes.
- Masks are no longer required in schools, including for staff, students and visitors.
- Masks are still recommended whenever you can't physically distance.
- Face masks are required outside of your home or accommodation if you have a temperature equal to or higher than 37.5 degrees, or if you have COVID-19 symptoms, or if you're awaiting a COVID-19 PCR test result
- Face masks are required if you're diagnosed with COVID-19, are a close contact, or are an international traveller (in accordance with other public health directions).

### - IMMEDIATE IMPLICATIONS FOR OUR GATHERINGS

- > Masks are no longer required
- Occupant Density Limits no longer apply
- Proof of COVID-19 vaccination is NOT required for entry to church

### **Communion / Agape meal (Sunday 6 March onwards)**

- You are not required to wear a face mask.
- You no longer have to book a seat.
- Please feel free to sit in any available seat.
- Choir and Orchestra will come down from the stage for the word session.
  - The removal of occupant density limits allows us to use up to 100% of our seated capacity. Therefore, we will no longer be using the Seat Booking System for the Auditorium.
- BYO morning tea (outdoors)
  - Please come prepared to participate in a BYO morning tea as part of our agape meal fellowship.
  - o To the extent possible, please continue to observe physical distancing recommendations.

### • Agape Fellowship (in homes)

- In addition to fellowship over morning tea on the Samford premises, everyone is exhorted to continue to fellowship over an agape meal in homes. Please take initiative to organise this for yourself and your household.
- Our priority is to continue *steadfastly in the apostles' doctrine and fellowship, in the breaking of bread, and in prayers.* Act 2:42. As we meet in this way, we are giving ourselves to reclaim our Sundays from all other initiatives, so that we may fellowship in one accord, praising God and eating our food with gladness and simplicity of heart. Act 2:46-47. Eph 5:15-16.
- This time of agape fellowship will include elements of prayer, testimony, and fellowship in the Word.
